### Community oversight of the project

The NSW Department of Planning and Environment (DPE) introduced Community Consultative Committees (CCCs) to increase opportunities for community participation in State significant projects and encourage proponents to engage with the community and other key stakeholders at all stages of these projects.

The purpose of the CCC is to:

- establish good working relationships and promote information sharing between the proponent, local community, stakeholder groups and councils on State significant projects;
- allow the proponent to keep the community informed about projects, seek community views on projects and respond to matters raised by the community; and
- allow the community to seek information from the proponent and give the proponent feedback on projects to assist with the delivery of balanced economic, environmental and social outcomes for the community.
